## SECTION 2 - COMPOSITION, INFORMATION ON INGREDIENTS

## **SECTION 3 – HAZARDS IDENTIFICATION**

Emergency Overview: Mists and spray are irritating to eyes.

Potential Health Effects:

Eyes: Contact with liquid may cause moderate irritation.

Inhalation: Normally does not cause irritation. High concentrations and prolonged contact may cause irritation of mucous membranes.

**Skin:** Can cause mild skin irritation.

**Skin absorption:** Very low risk of skin absorption.

Ingestion: Can cause mild intestinal irritation.

Other effects: Repeated exposure may cause central nervous system effects such as: headaches, dizziness, drowsiness, nausea, vomiting and incoordination.

Carcinogenicity: Non-Hazardous by WHMIS – OSHA criteria. Not listed by IARC, NTP or ACGIH.

Teratogenicity, Mutagenicity, Reproductive effects: No known effects.

## **SECTION 4 - FIRST AID MEASURES**

Eye: Immediately flush with warm running water for 15 minutes, holding eyelids open during flushing. If irritation persists, repeat flushing and obtain medical attention

immediately.

Skin: Immediately flush exposed area with mild soap and water for at least 10 minutes. Remove contaminated clothing and launder before reuse. If irritation persists or if

contact has been prolonged, obtain medical attention.

Inhalation: Immediately remove the affected victim to fresh air. If symptoms persist, obtain medical attention.

Ingestion: Do Not Induce Vomiting. If the person is fully conscious, rinse mouth with water and drink a glass of water. Obtain medical attention immediately. Never give anything by mouth if the victim is unconscious, is rapidly losing consciousness or is convulsing.

#### **SECTION 5 – FIRE FIGHTING MEASURES**

Flammability: Combustible liquid.

Flash Point: > 93°C.

Auto-ignition Temperature: N/A.

Sensitivity to static discharge: Expected to be sensitive when vapors are present between the lower and upper explosive point.

Sensitivity to Mechanical Impact: Probably not sensitive.

Extinguishing Media: Water fog and dry chemical.

Special Fire Fighting Procedures: Evacuate personnel towards a safe area. Cool containers with flooding quality of water. Avoid breathing decomposition vapours. Use self-contained breathing apparatus and full body protection.

Unusual Fire and Explosion Hazards: Direct water on hot containers may become a source of explosion and then flash back to the point of product discharge..

Hazardous Decomposition Products: Oxides of carbon and nitrogen.

### **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Leak and Spill Procedure: Evacuate area. Ventilate area. Collect for disposal. Clean up remaining materials from spill with suitable absorbent. Small spills may be absorbed with non-reactive absorbent (sand) and placed in suitable, covered, labeled containers. For large spills, provide diking or other appropriate containment to keep material from spreading. Prevent large spills from entering sewers or waterways. If diked material can be pumped, store recovered material in compatible drums for recovery or disposal. Observe all personal protection equipment recommendations.

## **SECTION 7 – HANDLING AND STORAGE**

Storage Requirements: Keep Out Of Reach Of Children. Keep container tightly closed. Store in a cool, dry place away from incompatible materials, sources of heat, sparks and flames. Do not store in areas where temperature exceeds 40°C.

#### SECTION 8 – EXPOSURE CONTROLS, PERSONAL PROTECTION

Engineering controls: General ventilation is usually adequate.

Respiratory protection: Not normally required if good ventilation is maintained. Breathing mask with organic vapour filter is recommended if product is used where ventilation is inadequate or if application is on a large surface.

Skin protection: Use impervious (rubber, nitrile) gloves.

Other protective clothing or equipment: Eye bath, Safety shower, Full protective clothing.
